CDAAHPERD Kathleen Kinderfather Award

The purpose of this award is to recognize a group or organization (not an individual), who may or may not be members of the Alliance but who, through their work in HPERD and/or Sport Education, has contributed significantly to CDAAHPERD and/or the state Associations that comprise CDAAHPERD. One award per year may be presented at the annual CDAAHPERD convention.

Recipient criteria includes:

- Has made important contributions to HPERD and/or Sport education from the vantage point of their profession.
- Outstanding leadership
- Community service
- Innovative teaching practices
- Children and youth program development
- Has demonstrated outstanding professional integrity
- Has made contributions significant to the mission of CDAAHPERD

Nomination/Selection Process:

Three letters of recommendation, along with the official nomination form, are to be submitted to the **CDAAHPERD** Recognition Chair by November 12, 2011.

Nominations will be reviewed by the Central District Recognition Committee. The Committee will classify each group nominated in terms of the criteria for the award into one of five groups:

- (1) Excellent to superior qualifications = 4 points
- (2) Outstanding to highly qualified = 3 points
- (3) Adequate to good qualifications = 2 points
- (4) Adequate to less qualified than others = 1 point
- (5) Not qualified = 0 points

An average of 2.75 or higher must be attained to be selected. The group with the highest average will receive the Kathleen Kinderfather Award.
